

ST. PAUL'S INTERNATIONAL LITERARY PRIZE CONDITIONS OF ENTRY

St. Paul's School will hold the twenty-first St. Paul's School International Prize for Literature in three languages: English, Spanish and Catalan. This contest is open to participants throughout the world. Presentation of the stories and participation in the competition presupposes complete acceptance of these conditions:

1.- The St. Paul's School International Prize for Literature will be awarded in each of the three languages to the winners in the three following categories:

 $1^{\rm st}$ Category: Born between 01/01/2009 and 31/12/2010 $2^{\rm nd}$ Category: Born between 01/01/2006 and 31/12/2008 $3^{\rm rd}$ Category: Born between 01/01/2002 and 31/12/2005

In the three categories the competition is for short stories. There is a free choice of theme.

- 2.- The stories must be original, unpublished, individual and with a maximum length of 1.000 words.
- 3.- Entries must be submitted through St. Paul's School website http://www.stpauls.es/en/literary-prize/
- 4.- The closing date for receipt of entries is 8th January 2021.
- 5.- There is a maximum of 200 participants per category and language. Entries will be registered in strict order of receipt.
- 6.- The jury will be made up of well-known figures from the world of arts, education and journalism.
- 7.- The jury's decision will be final and will be made known at the prize-giving ceremony to be held at St. Paul's School on 22nd April 2021. St. Paul's School reserves the right to change this date if this should be deemed necessary.
- 8.- A total of 9 prizes, of 400 € each, will be awarded. In each category there will be a prize for each of the three languages.
- 9.- In the event of the author being underage at the time of receiving the prize, it will be paid into a bank account in their name and their legal representatives will formally agree to destine the full amount towards the development, education and training of the author, and will not be able to use the money for any other purpose than these.
- 10.- Those short stories, which have not been awarded prizes, will be destroyed and there will be no feedback for the senders.
- 11.- The organisers reserve the right to select the best stories for publication, giving the authors the exclusive right of their exploitation in any shape or form, for whoever they choose and for the maximum period established by current law.
- 12.- The participants, and in the case of underage participants, their legal representatives, just by participating, fully accept the conditions of entry and therefore authorise St. Paul's to publish their name and photograph on the school webpage or in any other advertising material, promotion or publication related to the literary competition without any type of compensation.
- 13.- For purposes in managing the Literary Prize, Fundación Privada St. Paul's undertakes to comply with the provisions of Regulation 2016/679, of April 27, 2016, o the protection of natural persons regarding the processing of personal data and on the free movement of such data, as well as the current state regulation of data protection. Fundación Privada St. Paul's undertakes to maintain the strictest confidentiality and confidentiality on all information to which it has access pertaining to the Literary Prize, promising to use this information only for the completion of the contest.
- 14.- The organising committee will resolve any unforeseen eventuality.
